The Data We Collect (Data Protection)

Onsite CCTV

Britannia Harrison and Rowley, situated at Britannia House, Alington Road, Eynesbury, Little Barford, St.Neots, PE19 6YH, utilises a comprehensive CCTV system which operates on continuous record. All images are kept for a period no longer than 28 days until the data is overwritten. This period is activity and system set-up dependant.

Data stored locally and is accessible remotely for staff members only, and only used for the safety of out of hours visitors, whilst the offices are closed.

Images of staff and visitors will be captured and may be used for crime prevention and crime detection as well as for the safety of all customers and staff whilst accessing the premises. This CCTV is active 24 hours a day, 7 days a week.

Unless prior consent from staff or customers have been given, we shall not utilise any images captured for marketing, publication or communication to any external sources.
